Letter of the City Supervisor, Ormoc City, dated January 6, 1951

In order to cover the various expenses which were either incurred or
that may be incurred by the City Elementary School, I have the honor to
request the following reversion of funds from:

D-60(1)	P 750.00
D-61(1)	1,320.00

D-21-g	500.00
D-21-l	80.00
D-21-t	70.00

Repair of Salvacion Intermediate Sch. Bldg. 450.00

These transfers are very necessary to cover over-drafts in the dif-
ferent expense classifications. For instance, to the travel expense
classification were charged the travelling expenses of the athletic dele-
gations to Albura, Naval, Malitbog and Tacleban besides those incurred
by me in going to different barrier schools for the purpose of closer and
more effective supervision of classes. The supplies are very necessary
because without them, the school may be forced to stop functioning. The
repair of the Salvacion Intermediate School Building is very imperative.
Unless the present building is repaired, the resultant deterioration maybe
such as to recall that anecdote of "for want of a nail, the shoe was lost
and for want of a shoe, the horse was lost, ect."

RESOLVED FURTHERMORE, to respectfully request Mr. Felix De Veyra, City Supervisor, Ormoc City, to appear at the session hall on the next regular meeting of the Board to make further explanation and illumination of his request on the reversion of funds on the rest of the items under consideration;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City; to the City Engineer, Ormoc City and to Mr. Felix De Veyra, City Supervisor, Ormoc City.
