RESOLUTION NO. 12

WHEREAS, Councilor Guillermo T. Parrilla informed his colleagues of the Municipal Board, Ormoc City that Mr. Sancho Camarote who is a meat inspector claims for his salary from the month of January 1, 1950 to June 30, 1950 or a period of six(6) months of continuous services as such meat inspector and which services until date is not yet paid;

WHEREAS, His Honor the City Mayor, Ormoc City also manifested that the position of meat inspector was abolished in the last budget of the city due to his desire that instead of two meat inspectors there should be only one meat inspector as a measure of economy and which decision was concurred by the Board.

WHEREAS, be it known that altho the position aforementioned was abolished in the Budget, Mr. Sancho Camarote continued rendering services on the date aforementioned until the Department of Finance ordered the reinstatement of Mr. Sancho Camarote whose services are badly needed;

WHEREAS, the City Mayor further informed the Board, that Mr. Sancho Camarote is also a Civil Service Eligible best qualified to the position as ruled by the Department of Finance;

WHEREAFORE, the Board on motion of Vice Mayor Marcelo D. Bandalan seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved to appropriate the sum of P360.00 for salary of Mr. Sancho Camarote as Meat Inspector covering the periods from January 1, 1950 to June 30, 1950 equivalent to six months at P60.00 per month, per voucher No. 2066 as approved by Mr. Protasio Escoro, City Agricultural Inspector;

RESOLVED FURTHER, that the amount of P360.00 as above appropriated be taken from the salary savings of the Municipal Board(C-2-a-2);




