for the office of the Market Personnel and Meat Inspectors is not enough to
meet the estimated expenses made by the City Engineer, I have the honor to
request this Hon. Body that one stall along Rizal Street of the additional
building be converted to our Market Office.

This site is very applicable for office on the ground that roof is
elevated and the place is very near to the fish area where we concentrate
most of our work for collection.

RESOLVED FURTHERMORE, to request the City Engineer to accomplish immediately the work considering the project urgently needed to facilitate the daily service of the market superintendent for better collection.

RESOLVED FINALLY, to furnish copy of the resolution each to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Engineer, Ormoc City; to the City Auditor, Ormoc City and the Market Superintendent, Ormoc City.
