RESOLUTION NO. 17

WHEREAS, the City Supervisor, Mr. Felix de Veyra in official communication addressed to the Municipal Board of Ormoc City dated Dec. 21, 1950 informed the Hon. Body that it was unanimously voted that the Elementary School Athletic Meet will be held in Ormoc City next school year;

WHEREAS, in said communication, it was suggested that Ormoc City shall improve the athletic ground and that Ormoc City shall construct a semi-permanent grandstand and upon the completion of this requirement, Ormoc City shall be considered one of the athletic centers of the Division;

WHEREAS, the City Supervisor, Mr. Felix de Veyra further recommended in said communication 1st: That the project be commenced as early as possible in February, 1951; 2nd; that plans and specifications as well as supervision be done by the City Engineer; 3rd, that the amount of P6,000.00 be appropriated for the improvement of the athletic ground and 4th, that the amount of P10,000.00 be appropriated for the construction of a semi-permanent grandstand;

WHEREAS, said City Supervisor further manifested in the Hall of the Municipal Board during its deliberation that the present athletic ground of the Ormoc Elem. School is sufficient because the requirement to be illegal as athletic center is only 4 hectares and the City Elem. School ground of Ormoc City has 6 hectares;

WHEREFORE,

The Board, on motion of Councilor Felipe Adolfo, Chairman of the Committee on Schools, seconded by Vice Mayor, Marcelo D. Bandalan;

BE IT RESOLVED, as is hereby resolved, that the construction of a semi-permanent grandstand in the Elementary School site of Ormoc City and the improvement of the athletic ground of Ormoc Elementary School be sponsored by the Municipal Board of Ormoc City;

RESOLVED FURTHER, to respectfully request the City Engineer to prepare the plans and specifications for the construction of said semi-permanent grandstand, the same to be supervised by the City Engineer concern;




