WHEREAS, on communication of the City Health Officer, Dr. Petronilo L. Torres dated Nov. 20, 1950, said City Health Officer requested the Municipal Board to create a position of medical officer with a compensation of P200.00 a month to help him in his numerous official duties and obligation;

WHEREAS, the Chairman of the Committee on Appropriation, Hon. Flaviano Montesclaros, on 3rd indorsement dated Dec. 18, 1950 favorably recommended to the Municipal Board of this city, the creation of the position of Asst. City Health Officer, instead of medical officer, as suggested by Dr. Torres with a compensation of P200.00 a month;

WHEREFORE,

The Board, on motion of Councilor Felipe Adolfo, seconded by Councilor Pablo S. Pajaron;

BE IT RESOLVED, as is hereby resolved, to create the position of one Asst. City Health Office, Ormoc City as recommended in the aforementioned communication with a compensation at the rate of P200.00 per month, effective immediately upon assumption to office of the Asst. City Health Officer and upon approval of said position of the Director of Health, Manila;

RESOLVED FURTHER, to furnish copy of this resolution each to the Executive Secretary, Office of the President, Malacañan Palace, Manila; to the Secretary of Health, Manila; to the Director of Health, Manila; to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City; to the City Health Officer, Ormoc City;
