

I have the honor to request the creation ofpositions for two watchmen for the waterworks of Ormoc City. These men will work as additional watchmen for the reservoir and intake If the Ormoc Waterworks respectively, and will perform guard duty during the period from 6:00 p.m. to 6:00 a.m..

There is an imperative need for additional watchmen in order to provide utmost security to our only waterworks system serving the whole population of the City Proper. At present there is only one watchman each for the reservoir and intake and they are on duty from 6:00 a.m. to 6:00 p.m. only. Since a 24-hour service is required, and since the same could not be rendered by one man, 2 men each are required to guard the reservoir and intake.

It is suggested that the salary of these additional men be taken from the unexpended balance for the waterworks system, at the rate of P50.00 a month.

Your kind consideration is earnestly requested.
