The Board, on motion of Councilor Felipe Adolfo seconded by Vice Mayor Marcelo D. Bandalan;


BE IT RESOLVED, as is hereby resolved to appropriate the amount of P400.00 taken from the general fund of the city to be transferred to the city school fund for the immediate repair of the school house of Barrio Catmon in the sum of P270.00 and for the repair of the school house of Barrio Nasunogan in the sum of P130.00, respectively;

RESOLVED FURTHERMORE, that the amount of P400.00 as above appropriated be effected thru reversion of fund taken, specifically from the per diems of the city Councilors, and the salary savings of the City employees;


