Sir:

In view of the present need of a room for the Office of the Register of Deeds of this City, I propose and recommend approval by that Honorable Body to make one additional room in the Public Library Bldg. so that the room for the Municipal Court in that building may be occupied by the Register of Deeds while the proposed additional room and session hall will be used by the Municipal Court.

Inasmuch as there is no fund available for that project I recommend the amount of P500.00 set aside for the toilet of the Public Library Building, under Res. No. 195 dated Nov. 15, 1950, be used for the improvement of partition walls, doors, railing etc. for the proposed work so that the properties and other equipments belonging to the offices concerned will be safe.

For your information the estimated cost of the work is hereby submitted and the rest of the amount from the P500.00 will be used to cover the overdraft incurred by this Office for partitions ordered made recently in said building.



RESOLVED FURTHER that the amount of P500.00 as above appropriated, as recommended in the communication above quoted, be taken from the toilet fund;


