RESOLUTION NO. 11

WHEREAS, the Municipal Board of Ormoc City in its session on February 3, 1951 c.s. approved Resolution No. 18 hereto attached which is self-explanatory;

WHEREAS, in said resolution, the City Engineer of Ormoc was requested to submit a map or sketch showing the boundaries which will separate the municipality of Cananga and Ormoc City, indicating in said sketch the two rivers known as Bao and Pagsaingan River;

WHEREAS, Councilor Porfirio Ayuyao, Chairman on City Planning and Zoning, after due consultation with the City Engineer of Ormoc City and Honorable Congressman Domingo Veloso, Speaker Protempore, House of the Representatives, said City Engineer, Mr. Fernando Montes submitted to the Municipal Board during its special session on March 21, 1951 the attached sketch showing the new Bao River and Pagsaingan River separating the city of Ormoc from the Municipality of Cananga indicating in said sketch in dotted red line beginning from Post MBM No. 19 to MBM No. 20 down to Pagsaingan River crossing the Barrio of Monte Rico and the new Bao River beginning Post BBM No. 41 BBM No. 44 up to BBM No. 48;

WHEREAS, the Municipal Board of Ormoc City hereby respectfully request, Honorable Congressman Domingo Veloso to amend and specify the boundaries between Ormoc City and the Municipality of Cananga in his proposed amendment of Republic Act No. 542 so that the herein attached sketch indicating the boundaries of Cananga and the city of Ormoc, indicated by dotted red line as above described, be the boundary line that will be indicated in the proposed amendment of said Republic Act No. 542;

NOW THEREFORE, the Board on motion of Councilor Porfirio Ayuyao, seconded by Councilor Pablo S. Pajaron;

BE IT RESOLVED, as is hereby resolved, to respectfully request Congressman Domingo Veloso that the boundary line separating the Municipality of Cananga and the city of Ormoc as indicated in the attached sketch and more specifically described in the whereases aforementioned by indicated expressly in the proposed amendment of said Republic Act No. 542 in order to settle once and for all the problem on boundary line which separate the Municipality of Cananga and the city of Ormoc;






