BE IT RESOLVED, as is hereby resolved, to respectfully request Congressman Domingo Veloso that the boundary line separating the Municipality of Camenga and the city of Ormoc as indicated in the attached sketch and more specifically described in the whereases aforementioned by indicated expressly in the proposed amendment of said Republic Act No. 542 in order to sattle once and for all the problem on boundary line which separate the Municipality of Cananga and the city of Ormoc;
