RESOLUTION NO. 47

WHEREAS, the Municipal Board, Ormoc City on manifestation of Councilor Flaviano Montesclaros vigorously opposing the closing of Ormoc City High School, stressed the point that if the idea would be carried out, the City of Ormoc would be the only city throughout the Philippines without a city high school and, therefore, the Councilor strongly supported the idea that the Municipal Board of Ormoc City, should transfer the Ormoc City High School to the City Proper instead of closing the Ormoc City High School at Barrio Valencia;

WHEREAS, Councilor Victorino C. Teleron acting on the information of Mr. Carlos Petilla, Principal of Ormoc City High School to the effect that the City High School concern does not have enough enrolment to make it even a self-supporting institution, said Councilor proposed to create a committee to investigate the feasibility of transferring the Ormoc City High School from Valencia to the City proper, requesting the committee thus form, to report its recommendation on or before April 15, 1951;

NOW THEREFORE,


The Board, on motion of Councilor Victorino C. Teleron, seconded by Councilor Antonio C. Cataang;

BE IT RESOLVED, as is hereby resolved, to create a committee to be composed of Councilor Felipe Adolfo, as Chairman, Mr. Carlos Petilla, Principal, Ormoc City High School; as member; Mr. Camilo Rosello, Academic Supervisor, member and Mr. Felix De Veyra, City Supervisor member for the purpose of conducting and investigation on the feasibility of transferring the Ormoc City High School from Valencia to the city proper and to submit its report on or before April 15, 1951;


