During my campaign for enrollment in the Ormoc City High School, some parents urge me to request this Honorable Body to grant free tuition fee for every third child of a family that has three students enrolled in this school. Private schools are giving this privilege.

I strongly recommend the adoption of this policy-free tuition fee for every third child of a family that has three students in this school, in order to attract many students and help lighten the financial burden of families that have many students studying in the City High.

BE IT RESOLVED, as is hereby resolved to approved the request of the Principal, Ormoc City High School above quoted to the effect that for every three students of the same family enrolled in the Ormoc City High School the third having the lowest grade be given free tuition fees which is the same policy given to almost all High Schools and Colleges in order to give incentive to parents and students to enroll in the Ormoc City High School, thus to encrease enrollment;

RESOLVED FURTHER, to furnish copy of this resolution each to the Director of Public Schools, Manila; to the Division Superintendent of Schools, Tacloban, Leyte; to the City Mayor, Ormoc City, to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City and to the Principal, Ormoc City High School, Ormoc City.
