RESOLUTION NO. 52

1st Indorsement dated March 24, 1951 of the City Supervisor, Mr. Felix De Veyra, Ormoc City hereunder quoted verbatim as follows:

1st Indorsement
DIVISION OF LEYTE, ORMOC CITY DISTRICT
Ormoc City, March 24, 1951

Respectfully returned to the Hon. Municipal Board, thru Hon. City Mayor, Ormoc City, with the information that after careful study of the problems existing about the primary classes in this city, the Division Office has finally decided that the excess primary positions be utilized by assigning teachers to occupy these classes having combined grades or by splitting large enrolment into two classes. Attached is a copy of a circular letter issued by this office effecting such plan.

Consequently, the 16 positions created by the city in order to continue the services of those teachers who were laid off, shall be discontinued.

Please be informed also that 11 positions for principals in this city have been partly nationalized although they merely carry a salary item of a classroom teacher at P140 monthly. This is so because the division has no excess salary item for principals. However, principals are entitled to a salary of P160 as per Republic Act 312. In order to give due justice and fairness to the 11 principals whose lives have been humbly and willingly dedicated to the service of the school children in this city, and because the financial burden of the city has been minimized greatly by having these principals no longer paid from city funds, it is requested and humbly appealed that the amount of P2,640 be appropriated and to be taken from the return amount of P7,000 recently appropriated, to cover the salary difference of P20 monthly or P240 annually of each principal.

The Board, on motion of Councilor Pablo S. Pajaron, seconded by Councilor Victorino C. Teleron;


BE IT RESOLVED, as is hereby resolved, to approve the recommendation of the City Supervisor in the communication above quoted, appropriating the sum of P2,640.00 to cover the salary differential of 11 positions for principal teachers of the City Intermediate School which have been partly nationalized so as to entitle said city principal teachers to a salary of P160.00 per month as per Republic Act 312, which amount shall be taken from the salary savings of the city school fund;


RESOLVED FINALLY, to furnish copy of this resolution each to the Director of Public Schools, Manila; to the Division Superintendent of Schools, Tacloban,
