The Board, on motion of Councilor Pablo S. Pajaron, seconded by Councilor Flaviano Montesclaros,

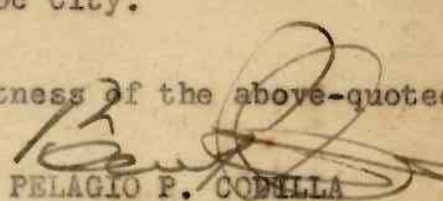

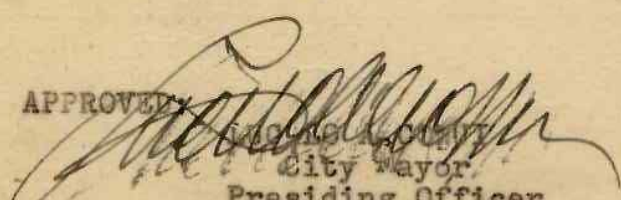
RESOLVED FURTHER, that the amount of P120.00 as above appropriated be taken from the salary savings of the police department;

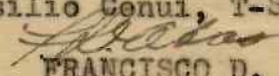
