Sirs:

Request that an appropriation be created by that body, in the amount of Five Hundred Pesos (P500.00) for the transportation and subsistence of Policemen while on official mission to Manila and some other places.

This appropriation has been omitted in the budget for this Fiscal Year.

It is recommended that this amount be reverted from the salary savings of this department.

The Board, on motion of Councilor Felipe Adolfo, seconded by Vice Mayor Marcelo D. Bandalan;

BE IT RESOLVED, as is hereby resolved, to appropriate the amount of P380.00 instead of P500.00 requested in the communication above quoted the same to be used for traveling and transportation expenses including subsistence of policemen for conducting prisoners to Manila and other places, which amount of P380.00 shall be taken from the salary savings of the Police Department concerned;

RESOLVED FURTHER, to correct the statement above quoted that no appropriation has been made for traveling expenses of policemen in said Police Department the fact being that

RESOLVED FINALLY, to respectfully advice the Chief of Police, Ormoc City, that communication of said Police Department address to the Municipal Board, Ormoc City be coursed thru proper channels to avoid delay and also to determine the availability of funds.

Let copies of this resolution be furnished each to the City Mayor, Ormoc City, City Treasurer, Ormoc City; City Auditor Ormoc City and Chief of Police, Ormoc City.
