WHEREAS, the Municipal Board, this city, taking into consideration the benefit that the people of Ormoc City would derive from the installation of telephone system;

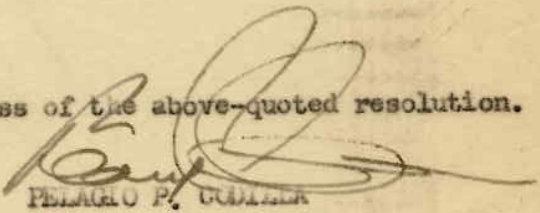
The Board, on motion of Councilor Felipe Adolfo, seconded by Vice Mayor, Marcelo D. Bandalan;

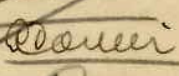
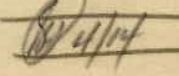

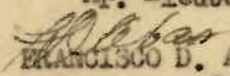
