Request that an appropriation be created for the payment of the difference in pay of Pat. Telesforo Arcuino, T/Sgt. Basilio Conui, Pat. Doroteo Remuneron, Pat. Macario Monte, Pat. Restituto Maraviles, Pat. Agapito Payud and Cpl. Ruperto Masias, in the amount of ONE HUNDRED SEVENTY-FIVE PESOS (P175.00) covering the period from July 1, 1949 to November 30, 1949, as per their approved appointments by the Civil Service Commission.

It is recommended that a part of the salary savings in the Police Department be reverted for the purpose.

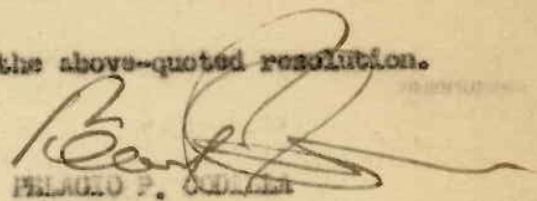

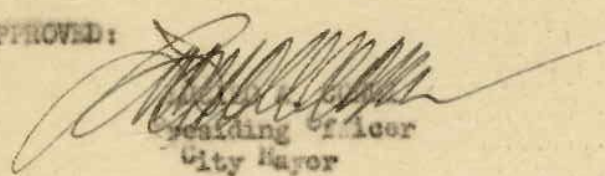
