Teleron that the construction of wooden table for dried and salted fish vendors for use in the new market extension be made at the expense of the salted and dried fish vendors which plans and specifications for said wooden table shall be made on the suggestion of the market superintendent subject to the approval of the city engineer, Ormoc City and the uniform expenses incurred for said wooden table for each and every market vendors for dried and salted fish, shall be gradually

reimbursed by exempting from payment of the daily market fees in favor of the interested fish vendors until the whole expenses shall have been fully coverned or reimbursed in which case the ownership of said wooden tables shall become automatically the property of the city government of Ormoc.
