RESOLUTION NO. 52

WHEREAS, on manifestation of Councilor Felipe Adolfo strongly suggesting that the amount of P500.00 be appropriated for the repair of the Artesian Well at Barrio Valencia, Ormoc City and further suggesting that the amount of P180.00 be appropriated for the installation and purchase two (2) pitchers pump at Barrio Linao and one (1) pitcher pump at Barrio Libertad near the school site of said Barrio;

The Board, on motion of Councilor Felipe Adolfo seconded by Councilor Pablo S. Pajaron;

BE IT RESOLVED, as is hereby resolved to appropriate the sum of P500.00 for the repair of the artesian well of Valencia which amount of P500.00 shall be taken from the items of the traveling expenses of the Municipal Board, Ormoc City;

RESOLVED FURTHER, that an amount of P180.00 be appropriated for the purchase and installation of two (2) pitchers pump for Barrio Linao and one (1) pitcher pump for Barrio Libertad, Ormoc City, the later to be installed just near the school site, and which amount of P180.00 shall be taken from the per diem savings of the members of the Municipal Board, Ormoc City;

RESOLVED FINALLY, to furnish copies of this resolution each to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City; to the City Engineer, Ormoc City; to the PTA President of Barrio Linao; the Barrio Lt., Valencia, Ormoc City; and to Mr. Gomez, Driller of Artesian Well.
