BE IT RESOLVED, as is hereby resolved, that a committee be created to make negotiation with the different land owners on both side of Bonifacio Street Extension to the end of the dike, in order to solve the problem of the squatters in the barrio Canlumpag and the squatters in the school site in the Ormoc Elementary School;




