RESOLUTION NO. 62

WHEREAS, during the inspection of the Hon. Members of the Municipal Board of this city of the new market extension tiendas preparatory to its acceptance, the Municipal Board on the suggestion of the market superintendent realized the imperative necessity of applying for additional loan from the Rehabilitation Finance Corporation for the construction of new market tiendas in the middle of the market premises as an extension of the old market which is partly destroyed during the last war and which amount of P60,000 of the new proposed loan would be partly used also in the repair said old market;

NOW THEREFORE, the Board on motion of Councilor Cleto P. Evangelista; seconded by Vice Mayor, Marcelo D. Mandalan;

IT IS RESOLVED, and it is hereby resolved, to authorize His Honor, Lucilo A. Conui, the City Mayor of Ormoc City to negotiate a new loan with the Rehabilitation Finance Corporation in the sum of P60,000 for the construction of new market tiendas on the vacant space inside the market premises as an extension of the old market which was destroyed during the last war, and which amount of P60,000 shall be used partly to repair the old market;

RESOLVED FURTHER, to respectfully request the Hon. Board of Governors of the Rehabilitation Finance Corporation, Manila to kindly consider and act favorably on the Representation hereby granted by the Municipal Board of His Honor, the City Mayor of Ormoc City in order that the best interest of the people of the city of Ormoc would be fully realized, thus increasing the income of the city which is essential in carrying out its undertaking for more public improvement;

RESOLVED FURTHERMORE, to respectfully convey to the Honorable Board of Governors of the R. F. C. and the Manager of the same, Hon. Jose Moran, that in so far as this new loan negotiation of P60,000 is concern, the same is still within the borrowing capacity of Ormoc City;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Board of Governors, of the R. F. C., Manila to the City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; and the City Engineer, Ormoc City;
