Sol VaD, as is hereby resolved to authorize the Market Superintendent concern to enter into a contract with private contractor for the construction of the wooden table a sementioned, the same to be financed in advance by the Salted and Dried Fish Vendors at the rate of \$\mathbb{P}42.60\$ per wooden table which expenses shall be reimbursed gradully by the City Government by exempting said vendors of the ried and Salted Fish from the daily rental in the market until the amount of \$\P\$42.60 shall have been fully covered, after which the ownership of said wooden table shall automatically become the property of the City Government as provided for in previous resolution of the Board.

RESOLVED FURTHER, to authorize as is hereby authorized the Market Superintendent concern to use his best judgement and discretion for the best interest of the City Government of Ormoc City and the public in general that after this wooden table shall have been made as above provided, no Salted and Dried Fish Vendors shall be allowed to run business outside the market extension premises as long as the exercise of discreation tends to adopt uniformity and aesthetic arrangement within the market premises with due observance to sanitary rules and regulations as prescribed by the City Health Department concern;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City and to the City Engineer, Ormoc City; to the City Health Officer, Ormoc City and to the Market Superintendent, Ormoc City.
