RESOLUTION NO. 68

WHEREAS, the Market Superintendent, Ormoc City in compliance with the previous resolution of the Board that the construction of wooden tables for Salted and Dried Fish Vendors in the new market extension be undertaken at the expense of said Dried and Salted Fish Vendors informed the Honorable Body that the plans and specifications of said wooden table for Salted and Dried Fish, duly approved by the City Engineer has reached the amount of P42.60 for every wooden table;

NOW THEREFORE, the Board on motion of Councilor Victorino C. Teleron, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved to authorize the Market Superintendent concern to enter into a contract with private contractor for the construction of the wooden table aforementioned, the same to be financed in advance by the Salted and Dried Fish Vendors at the rate of P42.60 per wooden table which expenses shall be reimbursed gradually by the City Government by exempting said vendors of the Dried and Salted Fish from the daily rental in the market until the amount of P42.60 shall have been fully covered, after which the ownership of said wooden table shall automatically become the property of the City Government as provided for in previous resolution of the Board.

RESOLVED FURTHER, to authorize as is hereby authorized the Market Superintendent concern to use his best judgement and discretion for the best interest of the City Government of Ormoc City and the public in general that after this wooden table shall have been made as above, provided, no Salted and Dried Fish Vendors shall be allowed to run business outside the market extension premises as long as the exercise of discretion tends to adopt uniformity and aesthetic arrangement within the market premises with due observance to sanitary rules and regulations as prescribed by the City Health Department concern;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City and to the City Engineer, Ormoc City; to the City Health Officer, Ormoc City and to the Market Superintendent, Ormoc City.






