RESOLUTION NO. 71

WHEREAS, it was brought to the official knowledge of the Municipal Board, Ormoc City that City Attorney, Primo L. Cabrera, of Ormoc City has in his position the amount of P700.00 which said City Fiscal, at his own instance, retained the said amount of P700.00 as a deposit under his personal custody and responsibility, the same to be delivered to the brothers of Mr. Gregorio Jabon who is in the island of Mindanao, upon his return to Ormoc City and which amount of P700.00 represent the share as co-owner of the land purchased by the PTA of Valencia and donated to the city government of Ormoc City for school site of Ormoc City High School at barrio Valencia;

WHEREAS, it is a known fact that City Fiscal, Primo L. Cabrera has tendered his resignation as City Fiscal and which resignation is still pending approval by his Excellency the President of the Philippines;

NOW THEREFORE, the Board, on motion of Councilor Victorino C. Teleron, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved, to respectfully request the City Fiscal Primo L. Cabrera that the amount of P700.00 retained by him as payment of the share of pro-inovise inheritance which correspond to the brothers of Mr. Gregorio Jabon who is still in Mindanao, be deposited with the City Treasurer of Ormoc City in the name of the brother of said Mr. Gregorio Jabon until said brothers would return to the City of Ormoc the same to be withdrawn by said brothers of Mr. Gregorio Jabon upon signing the Deed of Donation of their share and participation of the land used for school site of the Ormoc City High School at Valencia which the Valencia PTA purchased from Mr. Gregorio Jabon and his brothers Silverio and Francisco, both surnamed Jabon who are in Mindanao.




