RESOLUTION NO. 68

WHEREAS, the market superintendent Mr. Francisco Arradaza on manifestation during the session of the Municipal Board to the effect that Resolution No. 68 c.s. was verbally objected to by the City Treasurer of Ormoc City for the reason that the same is violative of existing rules and regulations, said market superintendent appealed to the Board for further consideration of the matter so as to accomplish the aim of providing wooden tables for dried and salted fish in the new market extension;

NOW THEREFORE, the Board, on motion of Councilor Felipe Adolfo, seconded by Pablo S. Pajaron;

BE IT RESOLVED, as it is hereby resolved that Resolution No. 68 c.s. be repealed;

RESOLVED FURTHER, to authorize, as it is hereby authorized the vendors of dried and salted fish interested to occupy a place to sell salted and dried fish in said new market extension, to enter into a contract with private person to prepare for them wooden tables according to plans and specifications of the market superintendent duly approved by the City Engineer, Ormoc City, which work shall be under the supervision of said market superintendent;

RESOLVED FURTHERMORE, that if the City Government of Ormoc shall have enough fund, the same, thru the Municipal Board, shall appropriate money to purchase said wooden tables for salted and dried fish, which shall not exceed the amount of P42.60 each as approved by the Board under Res. abovementioned so that said wooden tables shall become automatically the property of the city government;




