RESOLUTION NO. 74

WHEREAS, the City Engineer, Ormoc City in his official communication to the Chief of Police, this City, dated May 7, 1951, thru His Honor, the City Mayor, requested the authorities concerned to advise those people living within the City Hall site (squatters) without building permits more specifically along the shore line of Ormoc Bay to refrain from repairing their respective houses which were damaged by the last typhoon;

WHEREAS, on even dated, May 7, 1951, Mr. Francisco D. Abas, Secretary to the City Mayor addressed a letter to the Hon. Municipal Board thru the City Mayor, this City requesting that efforts be exerted by the authorities concerned to find means and ways of solving the plight of these poor squatters who are refrained to repair their houses damaged during the last typhoon;

WHEREAS, Councilor Felipe Adolfo strongly suggested that in order to solve the housing problem of the squatters living along the shore line of Ormoc Bay and those living within the City Hall site should be assigned a site where to construct their houses on public lands along Anilao River which should be applied by the City Government according to sketch annexed to this resolution requesting the Director of Lands, Manila to give preference to the application of the City Government of Ormoc.

NOW THEREFORE,

The Board, on motion of Councilor Felipe Adolfo, seconded by Vice-Mayor Marcelo D. Bandalan,

BE IT RESOLVED, as is hereby resolved to respectfully request the representation of the Bureau of Lands, Mr. Rufino I. Pascual, Ormoc City to furnish the Municipal Board of Ormoc City with sketch or map of lots owned by the National Government within the City of Ormoc, specifically along Anilao River and barrio Alegria and other places near the City Proper the same to be attached to this Resolution and which Lots appearing in said sketch or map shall be applied for lease by the City Government, Ormoc City from the Bureau of Lands in order to solve the squatters housing problem of the City of Ormoc;

RESOLVED FURTHER, to respectfully request the City Treasurer, Mr. Menandro J. Tavera, Ormoc City to furnish the Municipal Board this City with lists of City lots and owned by the City Government, specifically within or near the city proper, the same to be used as squatters site for those people who are willing to reside therein, thus solving the plight of the squatters who are not allowed to construct house along Ormoc Bay and within the City Hall site;

RESOLVED FURTHERMORE to respectfully request the City Treasurer, Ormoc City and Mr. Rufino I. Pascual, local representative of the Bureau of Lands, Ormoc City to appear at the Session Hall, Ormoc City on May 26, 1951 at 10:00 o'clock A.M. bringing with them list of city lots and their location and also on the part of Mr. Rufino I. Pascual to bring with him sketch or map of lots owned by the National Government along Anilao River, Bo. Alegria and other places near the city proper so that the squatters having problem could be fully deliberated by the Board;

RESOLVED FINALLY, to furnish copy of this resolution to the Director, Bureau of Lands, Manila, to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Engineer, Ormoc City; to the City Auditor, Ormoc City; to the City Health Officer, Ormoc City and to Mr. Rufino I. Pascual, Ormoc City.
