RESOLUTION NO. 89

WHEREAS, Vice Mayor Marcelo D. Bandalan, called the attention of the Honorable Body, the necessity of sending to Manila a committee of two, composed of Councilor Felipe Adolfo and Co Councilor Pablo S. Pajaron, to make official representation with the authorities concerned in Manila with the help of Honorable Congressman Domingo Veloso, Speaker Protempore of the House of Representatives to accomplish the following purpose:

FIRST, to expedite the immediate release of typhoon aid for the City of Ormoc, per Resolution No. 77 c.s. of the Municipal Board;

SECOND, to expedite the requisition of a Bronze Plaque per Resolution No. 185, series of 1950 of the Municipal Board;

THIRD, to expedite the release of Hospital Aid for Ormoc City per Resolution No. 118, series of 1950 of the Municipal Board of Ormoc City;

NOT THEREFORE,

BE IT RESOLVED, to appropriate P600.00 cash advance for the traveling expenses back and forth at P300.00 for each councilor which amount so appropriated shall be taken from the salary savings of the Municipal Board, Ormoc City;

RESOLVED FURTHER, to respectfully request the authorities concerned in Manila to kindly attend to the committee above created so that with the aid and representation of Honorable Domingo Veloso their mission as above enumerated, would be accomplished;

RESOLVED FINALLY, to respectfully request the committee herein created to bring with them excerpts of the resolutions of the Board aforementioned, for their guidance;

Let copies of this Resolution be furnished, each to the Executive Secretary of the President, Malacañan Palace, Manila; to the Director of Public Works and Communication, Manila; to the Director of the Bureau of Health, Manila; to the Honorable Secretary of Finance, Manila; to the Honorable Congressman Domingo Veloso, Speaker Protempore, House of Representatives, Manila; to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City; to the City Eng. Ormoc City and to the City Health Officer, Ormoc City.
