RESOLUTION NO. 93

WHEREAS, Dr. Wincelao Pongos, member of the Church Reconstruction Committee, in open session before the Hon. Body, strongly suggested to exempt the Church authority of Ormoc City the enforcement of Resolution No. 153, series of 1948 on widening of City streets to 10 meters in front of the Church on Arradaza street so that in the reconstruction of the Roman Catholic Church at Ormoc City the walls of said Church facing Arradaza street would not be demolished. And in order to carry out the widening of City streets to 10 meters as per resolution aforementioned the same should be effected by setting the required distance of 10 meters from the portion of the plaza facing the church premises on Arradaza street instead of demolishing the church wall and see to it that the aesthetic view required by City Planning and Building Ordinance would not be affected;

WHEREAS, the City Engineer, Mr. Fernando Montes who was present during the meeting of the Board upon consultation by the Honorable Members of the deliberative body offered no objection to the suggested plan of exempting the local church authority on the operation of said resolution No. 153 to widen both sides of the streets to 10 meters;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Porfirio Ayuyao;

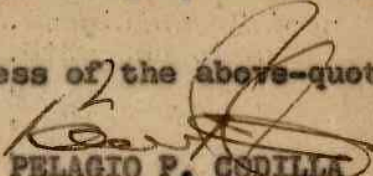
BE IT RESOLVED, as is hereby resolved, to exempt the Church Authority of Ormoc City from the enforcement of Resolution No. 153, series of 1948 from removing the wall of the church on Arradaza street facing the plaza as required by said resolution;

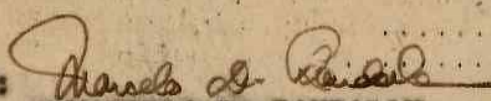
RESOLVED FURTHER, that in order to carry out the required distance of 10 meters provided for in said resolution in the widening of City streets, the same should be effected by taking that portion of the plaza in front of the Roman Catholic Church of Ormoc City on Arradaza street without demolishing the church wall but always preserving the aesthetic view required by City Planning and Zonification Ordinance of the City of Ormoc;
