Dear Director Fernandez:

I strongly recommend the conversion to national road
of the following provincial roads in the province of Leyte:

1. Baybay-Ormoc Road - - - - - 42 kms,
2. Bato-Libagon Road - - - - - 60 kms.

these roads are sent to your Office sometime ago.

BE IT RESOLVED, as is hereby resolved, to respect-
fully indorse for approval of the Director of Public Works,
Manila the above quoted recommendation of Congressman
Domingo Veloso by converting the Ormoc City roads into a
National Road specifically the road between Ormoc to the
boundary line between Ormoc-Albuera Road as part of Bay-
bay-Ormoc Road in conformity with the above quoted recom-
mendation;
