Letter of Congressman Domingo Veloso, Speaker Pro-tempore, House of the Representatives, Manila, dated February 17, 1951 addressed to the Director of Public Works, Manila hereunder quoted verbatim as follows:

Dear Director Fernando:

I strongly recommend the conversion to national road of the following provincial roads in the province of Leyte:

1. Baybay-Ormoc Road - - - - 42 kms,
2. Bato-Libagon Road - - - - 60 kms.

BE IT RESOLVED, as is hereby resolved, to respectfully indorse for approval of the Director of Public Works, Manila the above quoted recommendation of Congressman Domingo Veloso by converting the Ormoc City roads into a National Road specifically the road between Ormoc to the boundary line between Ormoc-Albuera Road as part of Baybay-Ormoc Road in conformity with the above quoted recommendation;
