RESOLUTION NO. 100

1st WHEREAS, be it known that with special reference to the 1st indorsement of the Division Supt. of Schools, Tacloban, Leyte, dated July 6, 1951, the Municipal Board of Ormoc City is confronted with a new problem of opening High School classes of the Ormoc City High School at barrio Valencia which is now holding classes and in the city proper;

WHEREAS, be it known further that the opening of the Ormoc City High School classes at the city proper and at barrio Valencia is found by the authorities concerned to be more conducive to make the Ormoc City High School self-supporting;

WHEREAS, be it known finally, that it is the desire of the Municipal Board of this city, to accommodate all the high school students of the Ormoc City High School who petitioned the Municipal Board to open classes at the city proper to the satisfaction of their parents;

NOW THEREFORE, the Board, on motion of Vice Mayor, Marcelo D. Sandalan, seconded by Councilor Flaviano Montesclaros;

BE IT RESOLVED, as is hereby resolved to respectfully request the Division Supt. of Schools, Tacloban, Leyte to permit the opening of High School classes of the Ormoc City High School both at barrio Valencia and the city proper;

RESOLVED FURTHER, to respectfully convey to the Division Supt. concerned at Tacloban, Leyte that the opening of High School classes of the Ormoc City High School, both at barrio Valencia and the city proper, have the strong and solid support of the P.T.A. of barrio Valencia and the P.T.A. President of the City proper; thus making the Ormoc City High School, not only self-supporting, but a blessing to the parents and the students;

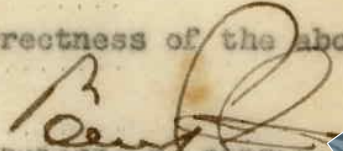
RESOLVED FURTHERMORE, to respectfully convey to the Division Supt. concerned, that the solution of the High School problem of the Ormoc City High School, as above stated, is the only way or the only solution which the local authorities concerned believe to be most conducive to the accommodation of all high school students of the Ormoc City High School who are now waiting for enrolment, to the satisfaction of the people of Ormoc City;

RESOLVED FINALLY, to respectfully request the Division Supt. of Schools, Tacloban, Leyte, that considering the urgency of the matter and so as to avoid delay to the prejudice of the parents and their students who are now waiting to be enrolled, that the decision be given on or before July 17, 1951. And for this purpose, be it known that any other resolution or resolutions which are inconsistent herewith are hereby revoked;

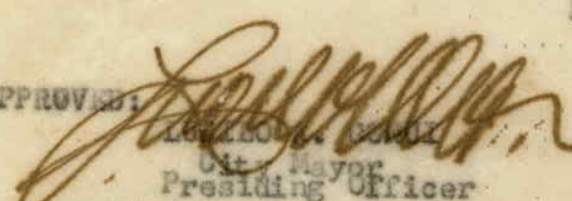
