Gentlemen:

Because of very urgent necessity, I have the honor
to request the use of the 10 city intermediate positions
(created by the Hon. City Municipal Board to reinstate
the 10 laid-off national municipal teachers on March 9,
1951) due to the increase city intermediate enrolment.

For the information of the Hon. City Municipal
Board, there were 55 city intermediate teaching posi-
tions last school year which already includes the 10
positions being recommended to accomodate the excess
pupils enrolled.

As it is now, Ormoc I has a total of 40 intermediate
teaching positions from the 55 total number of positions
for the whole city.

Inclosed is a list of the intermediate teachers in
Ormoc I at present showing their grade assignment, enrol-
ment and the school where they are assigned.
