BE IT RESOLVED, as is hereby resolved, to respectfully request Hon. Congressman Domingo Veloso and the authorities concerned in Manila to take official notice of 15 additional barrios created by the then Municipal Council of Ormoc now Municipal Board of Ormoc City since the census of 1939 up to the present, the recognition of which being urgent and important for the establishment of election precinct, namely:
