RESOLUTION NO. 103

WHEREAS, be it known that the Municipal Board of Ormoc City, has under its consideration a duly signed petition of the residents of Sitio Bocoy, Maganhan, Cabuabuhan, Manibon and Cagdaat who expressed their desire to convert the aforementioned sitios into an official barrio to be called barrio Domonar;

WHEREAS, actually the sitios aforementioned which is proposed to be created into barrio Domonar form an integral part of barrio Cava under the jurisdiction of Ormoc City;

NOW THEREFORE,

The Board, on motion of Vice Mayor Marcelo D. Bandalan, seconded by Councilor Porfirio Ayuyao;

BE IT RESOLVED, as is hereby resolved to approve the petition of the people living in sitios Bocoy, Maganhan, Cabuabuhan, Manibon and Cagdaat to constitute the aforementioned sitios into an official barrio to be called barrio Domonar;

RESOLVED FURTHER, to respectfully inform the people of the sitios aforementioned thru their representative Mr. Eutiquiano Donayre of the approval of the Board converting the sitios aforementioned into barrio Domonar subject however, to final approval of the authorities concerned in Manila;

RESOLVED FINALLY, to furnish copies of this resolution each to the Chief of the Local Government, Office of the President, Malacañan Palace, Manila; to Hon. Congressman Domingo Veloso; Speaker Protempore, House of the Representatives, Manila; City Mayor Ormoc City; City Treasurer, Ormoc City; City Engineer, Ormoc City; Chief of Police, Ormoc City; City Health Department, Ormoc City; Municipal Court, Ormoc City; and to the Office of the City Attorney, Ormoc City and to Mr. Eutiquiano Donayre Bocoy, Ormoc City.
