Gentlemen:

I have the honor to request that Honorable Body to pass a resolution granting authority to Gregorio Jabon, Eusebio Jabon, Silverio Jabon and Victoria Jabon to withdraw the amount of SEVEN HUNDRED PESOS (P700.00) which has been deposited in the office of the city treasurer, this city, by virtue of resolution number 61 dated April 15, 1950.

The said amount is supposed to be the last instalment payment for the school site at Barrio Valencia, Ormoc City sold for P1,700.00 by the above mentioned vendors to the city of Ormoc, which amount was donated by the P.T.A. of District II of said city.
