BE IT RESOLVED, as is hereby resolved, to respectfully convey to the Office of the City Engineer, Ormoc City that a free-use of water from the Ormoc Waterworks System be extended to Mr. Aurelio Sanchez effective upon the date of the approval of this resolution;
