RESOLUTION NO. 112

WHEREAS, be it known that it has been the popular clamor of the inhabitants of the barrios along the national highways of the city of Ormog requesting the authorities of said city to asphalt the streets fronting their barrio in order to give them improved sanitary condition conducive to their health;

WHEREAS, be it known further that acting on the popular request of the barrio people as above stated the city authorities of Ormog City requested the opinion of the City Engineer of Ormog City to kindly give preferential attention to the request of the barrio people living along the national highways in order to instill in their minds that the present administration has at heart serves their best welfare, specially on their common interest on sanitary condition and progress;

WHEREAS, the City Engineer concern acting on the request of the Municipal Board of Ormog City manifested his willingness to accede to the patriotic request of the Municipal Board provided the authorities concern in Manila would offer no objection;

NOW THEREFORE, the Board, on motion of Councilor Porfirio Ayuyao, seconded by Councilor Felipe Adolfo;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Secretary of Public Works and Communication, Manila; and the Director of Public Works, Manila; requesting their generous consideration to authorize the City Engineer of Ormog City to give preferential consideration to the popular clamor of the barrio people whose barrio sites are along the national highways of Ormog City to asphalt the national road fronting their barrios site the same being very essential to health and progress which is the concern of the present administration;

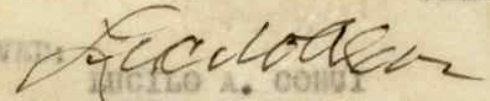
