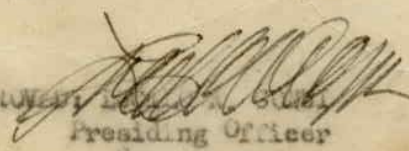
NOW THEREFORE, the Board, on motion of Councillor Felipe Adolfo, seconded by Councillor Flaviano Montesclaros;

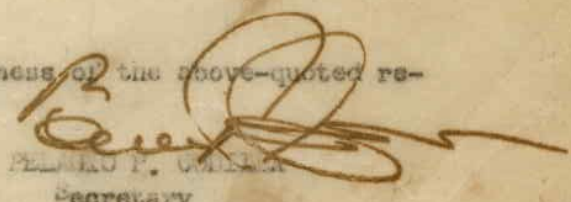

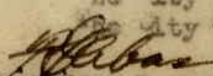
