(RESOLUTION NO. 125)

WHEREAS, on manifestation of Mr. Felix de Veyra and Mr. Camilo Rosello, District Supervisor, Ormoc District II and Academic Supervisor of the West Coast of Leyte respectively requesting the Board that sixty (60) extension positions for primary grades allocated for Ormoc City be given each a salary at P140.00 per month, considering that these positions are now being occupied by E.T.C. graduates;

NOW THEREFORE, the Board, on motion of Councilor Felipe Adolfo, seconded by Councilor Porfirio Ayuyao;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Hon. Secretary of Public Instruction, Manila that the original 60 extension positions allocated for Ormoc City as part of the 100 extension positions for the entire province of Leyte, be given each a salary at the rate of P140.00 per month as these positions are presently occupied by E.T.C. graduates, the same being in conformity with Republic Act No. 312;

RESOLVED FURTHER, to respectfully request the Hon. Secretary of Public Instruction that inasmuch as out of the 60 extension positions aforementioned only 12 were approved with a salary at P140.00 each and that the rest were reduced to P100.00 a month, those positions which were deprived of the privilege granted by said Republic Act No. 312 be reconsidered, and that the positions concern be given their respective salary differential;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Secretary of Public Instruction, Manila; to the Division Supt. of Schools, Tacloban, Leyte; to the City Mayor, Ormoc City; the City Treasurer, Ormoc City; City Auditor, Ormoc City, to Mr. Camilo Rosello, Ormoc City and to Mr. Felix De Veyra, Valencia, Ormoc City.
