RESOLUTION NO. 12

WHEREAS, Councilor Porfirio Ayuyao requested the Municipal Board of Ormoc City that the 5 intermediate teachers in Ormoc District II which will be laid off effective Sept. 8, 1951 by order of the Division Supt. of Schools, Tacloban, Leyte, that the effectivity of their being laid off be extended to Sept. 30, 1951;

WHEREAS, it was further manifested by said Councilor that the reason of the extension of separation from services of the five intermediate teachers aforementioned is to give chances to these teachers aforementioned who will be laid off to utilize their services to take the place of those teachers who will file maternity leave within the extended period specifically up to Sept. 30, 1951;

WHEREAS, it was further manifested to request the District Supervisor of Ormoc District II to give the Municipal Board concern the names of those 5 intermediate teachers of Ormoc District II supposed to be laid off;

NOW THEREFORE, the Board, on motion of Councilor Porfirio Ayuyao, seconded by Councilor Pablo S. Pajaron;

BE IT RESOLVED, as is hereby resolved, that the five (5) intermediate teachers who were ordered laid off on Sept. 8, 1951 by order of the Division Supt. of Schools, Tacloban, Leyte the effectivity of their separation from service be extended up to Sept. 30, 1951, the same being necessary in order to give chance to utilize the services of those teachers to take the place of those who will file maternity leave within the extended period;

RESOLVED FURTHERMORE, to respectfully request the District Supervisor of Ormoc District II to furnish the Municipal Board concern with the names of those teachers supposed to be laid off;

RESOLVED FINALLY, to furnish copy of this resolution each to the Division Supt. of Schools, Tacloban, Leyte; to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City; and to Mr. Felix De Veyra, Valencia, Ormoc City.
