RESOLUTION NO. 134

WHEREAS, the Municipal Board of Ormoc City highly impressed by the excellent services of the P.A.L. as one of the ten best commercial aviation enterprise in the world today thru the able and excellent management of its Board of Directors and considering that because of its huge profit it is now employing more than 1,800 Filipino workers and considering further that after due investigation the City of Ormoc, if included in its aerial line, its business would be enhanced and more people would be employed, the authorities concerned in Ormoc City respectfully request the Board of Directors of the PAL to extend facilities to Ormoc City by establishing Air Line connection;

WHEREAS, it is known that Ormoc City is one of the most progressive agricultural region in the province; the only place in Leyte which has a most progressive Sugar Central, and no doubt taking into consideration her potential wealth, her prospect in the business world is naturally bright;

WHEREAS, to realize the desire of the authorities concern the Municipal Board of Ormoc City respectfully appeals to Hon. Speaker Pro-tempore Domingo Veloso and to all Congressmen of Leyte, to Hon. Mariano Cuenco, Senate President and to Hon. Pio Pedrosa, Ex-Secretary of Finance, to contribute substantial financial aid from their share in the pork barrel to construct in Ormoc City an ideal air field landing;

NOW THEREFORE, the Board, on motion of Councilor Felipe Adolfo, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Hon. Board of Director of the Philippine Air Lines, Manila to extend air line connection to Ormoc City and to recommend to the authorities concerned in Manila for the construction of a new air landing field or the repair of the old one;

RESOLVED FURTHER, to respectfully request Hon. Congressman Domingo Veloso, Speaker Pro-tempore, house of the representatives, Manila, Hon. Mariano J. Cuenco, Senate President and Hon. Pio Pedrosa, Ex-Secretary of Finance, Manila to find means and ways of materializing the desire of the Municipal Board, Ormoc City to extend landing facilities of the PAL, the same to be financed by the national government ;




