RESOLUTION NO. 137

WHEREAS, the Presiding Officer of the Municipal Board, Ormoc City informed his colleagues on many complaints of water consumers of the Ormoc Water Works System on the amendment of Ordinance No. 6 Section No. 15 letter "A" series of 1948 increasing the flat rate fee of the consumer of the Ormoc Water Works System from P2.00 to P5.00 a month for consumers having or consisting of from one to five occupants; from P3.00 to P7.00 a month of family consisting of from six to 10 occupants; from P4.00 to P10.00 a month of consumers consisting of 11 members or more; and for water consumers for commercial use from P8.00 to P15.00 a month;

WHEREAS, Councilor Flaviano Montesclaros further brought to the attention of the Presiding Officer that the condition precedent on the amendment of our ordinance increasing water fees on the flat rate basis was that the same should be enforced only if the city government or the city engineer of Ormoc City could furnish all water consumers with meters which until now said condition is not yet fulfilled;

NOW THEREFORE, the Board, on motion of Councilor Felipe Adolfo, seconded by Councilor Flaviano Montesclaros;

BE IT RESOLVED, as is hereby resolved to suspend the enforcement of Section 1 of Ordinance No. 10 series of 1951 covered by Resolution No. 121 c.s. increasing water fees on flat rate abovementioned and to suspend likewise the operation and enforcement of Executive Order No. 10 series of 1951 of His Hon. the City Mayor, Ormoc City until the city government could provide all water consumers of Ormoc City with water meters;

RESOLVED FURTHER, that water fees for water consumers on flat rate basis shall be at its status quo changing the same fees as provided for in Ordinance No. 6 Section 15 letter "A" series of 1948 thus partly amending Ordinance No. 10 series of 1951;

RESOLVED FURTHERMORE, to respectfully request the City Engineer, Ormoc City to order the suspension immediately effective Sept. 30, 1951;

RESOLVED FINALLY, to furnish copy of this resolution each to the Executive Secretary, Malacañan Palace, Manila; to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; City Auditor, Ormoc City; City Engineer, Ormoc City; Municipal Judge, Ormoc City and the City Attorney, Ormoc City.
