RESOLUTION NO. 111

WHEREAS, Vice Mayor Marcelo D. Bandalan respectfully conveyed to the Hon. Body the desire of the people living in sitio Bagong to form themselves into a new barrio separate and independent from the barrio of Dolores;

WHEREAS, the new barrio of Bagong if finally approved by the authorities concern comprises the following jurisdictional limit with the following boundaries: North, Anilao River; East, Forest; South, Can-ale Creek; West, Barrio Magaswe Boundary, forming a square bounded in all its direction by straight line;

WHEREAS, Vice Mayor Marcelo D. Bandalan informed the Hon. Members of the Municipal Board, Ormog City on the petition of the people of the proposed Barrio of Bagong requesting the sanction of the Municipal Board on the regulation governing the activities in connection with the construction of barrio school and barrio chapel that their regulation duly agreed by the people of said Barrio on the construction of their barrio school and barrio chapel and the penalties provided for in their agreement be made binding to the people living in said proposed barrio, in so far as they are consistent with the laws and constitution of the Republic of the Philippines;

NOW THEREFORE, the Board, on motion of Vice Mayor Marcelo D. Bandalan, seconded by Councilor Felipe Adolfo;

BE IT RESOLVED, as is hereby resolved, to approve the desire of the people living in sitio Bagong to convert said sitio into a new barrio which shall be officially called Barrio Bagong separate and independent from barrio Dolores where it formerly belonged;

RESOLVED FURTHER, to respectfully request Hon. Congressman Domingo Veloso, Speaker Protempore, House of the Representatives, Manila for congressional action on the petition of the people of sitio Bagong converting said sitio into a new barrio to be officially called barrio Bagong separate and independent from that of barrio Dolores, which new barrio if finally approved by the authorities concern in Manila, shall have the following jurisdictional limit to be bounded on the North by Anilao River; on the East, Forest; on the South, Can-ale creek; and on the west barrio Magaswe boundary, forming a rectangle or square bounded by straight line in all four directions;

RESOLVED FURTHERMORE, to approve the petition of the people of Sitio Bagong who desire to form and constitute themselves into a barrio aforementioned requesting the Municipal Board of Ormoc City to sanction their regulation affecting their proposed activity to construct a barrio school and barrio chapel wherein the inhabitants living in said proposed barrio of Bagong bind themselves to abide with the order of their barrio Lt. regarding the activities aforementioned including the acquisition thru donation of school site of the purchase of the same in the amount of P200.00 which should be paid by the barrio people thru voluntary contribution; and in order to prosecute and accomplished all activities incidents to the complete accomplishment of the proposed barrio in so far as they are consistent with our laws and the constitution of the Republic of the Philippines, the Municipal Board of Ormoc City hereby sanctions the unanimous agreement of the people living in the proposed barrio to abide with the laws and regulation that shall be prescribed and enforced by the Barrio Lt. of the proposed barrio of Bagong;

RESOLVED FINALLY, to furnish copy of this resolution each to the Executive Secretary, Malacañan Palace, Manila; to Hon. Mariano Cuenco, Senate President, Manila; to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City; to the City Engineer, Ormoc City; to the City Health Officer, Ormoc City; Chief of Police, Ormoc City; Municipal Court, Ormoc City; City Attorney, Ormoc City and the Barrio Lt. of the proposed barrio of Bagong, Ormoc City.

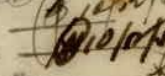

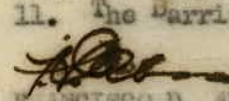
