RESOLUTION NO. 14

WHEREAS, Councilor Felipe Adolfo brought to the attention of the Honorable Body that a group of vaccinators are assigned in the City of Ormoc by order of the Director of Health, Manila to conduct a thorough vaccination campaign to the entire population of Ormoc City;

WHEREAS, Councilor Felipe Adolfo further informed the Board that there are existing vacant positions of vaccinator in the Department of Health, Manila to be assigned in the City of Ormoc according to reliable sources;

WHEREAS, it is known that in the city of Ormoc, there are many graduates in the high school who are looking for employment and in order to partly solve the unemployment problem in the city of Ormoc the Director of Health, Manila is hereby requested to employ high school graduates in Ormoc City who are willing to work as vaccinators after undergoing proper training;

NOW THEREFORE, the Board, on motion of Councilor Felipe Adolfo, seconded by Vice Mayor Marcelo D. Bandalan;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Hon. Director of Health, Manila to give preference to high school graduates of Ormoc City in matters of appointing vaccinators for the City of Ormoc for the reason that if they are appointed, these high school graduates from Ormoc City are well acquainted with the people of the city and it would partly solve the unemployment problem of the local government;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Director of Health, Manila; City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; City Health Department, Ormoc City; Police Department, Ormoc City; the Western Leyte College, Ormoc City; Saint Peter's Academy, Ormoc City and to the Ormoc City High School, Ormoc City.
