RESOLUTION NO. 146

WHEREAS, Vice Mayor Marcelo D. Bandalan informed the Hon. Body that on his visit together with Mr. Camelo Rosello, Academic Supervisor to the dike just near the school ground of the Ormoc Elementary School, he found out that the old dike which was partly destroyed by bump shell during the liberation, there are scattered stones which the people nearby who are squatters utilized said stones to improve the ground under their houses;

WHEREAS, be it known that the play ground of the Ormoc Elementary School is now being improved because of the approaching athletic meet which will be held in the city of Ormoc;

WHEREAS, be it known further, that actually, there are craters on the play ground of the Ormoc Elementary School caused by bump shells during the fight for liberation which requires filling;

WHEREAS, be it known finally, that it would be economical to the city government to utilize the scattered stones in the old dike aforementioned to cover the craters in the school ground;

NOW THEREFORE, the Board, on motion of Vice Mayor Marcelo D. Bandalan seconded by Councilor Pablo S. Pajaron;

BE IT RESOLVED, as is hereby resolved, to authorize Mr. Camelo Rosello, Academic Supervisor and concurrently supervisor of Ormoc District I to utilize the scattered stones of the destroyed old dikes which is near the Elementary School play ground to cover or fill up the craters around said play ground in order to accomplish the work of improving the same before the date set for the athletic meet this coming October 20 in Ormoc City;


RESOLVED FURTHER, to respectfully request Mr. Camelo Rosello the Supervisor aforementioned, to see to it that in transferring these scattered stones from the old dike to cover the craters on the play ground of the Ormoc Elementary School, the school children under his institution not utilized in carrying big stones as it would endanger the children to do this work;


