RESOLUTION NO. 119

WHEREAS, be it known that a deed of donation was executed by and between the donors in the name of Juana Vda. de Palo, Maria Palo de Tan, Laura Palo and Rita Palo de Barzabal on the one hand, and the city government of Ormoc represented by His Hon. Lucilo A. Conui, City Mayor of Ormoc City as donee on the other hand, on a portion of land known as Lot 2185 of Ormoc Cadastre situated at barrio Catayum Ormoc City with a superficial area of 25 sq.m. donated expressly as a site for the construction of public artesian well at barrio Catayum, Ormoc City and which instrument of donation was executed before Notary Public Pascual Perciles dated Sept. 25, 1951 and in which instrument, the donation was formally accepted by the City Mayor of Ormoc City representing the city government;

WHEREAS, be it known further, that by virtue of the aforementioned donation, Councilor Pablo S. Pajaron manifested that whatever appropriation for the construction of artesian well for the city of Ormoc the barrio of Catayum be given priority for the simple reason that a site for the construction of artesian well is already assured by virtue of the donation aforementioned;

AND THEREFORE, the Board, on motion of Councilor Pablo S. Pajaron, seconded by Councilor Porfirio Ayuyao;

BE IT RESOLVED, as is hereby resolved, to formally sanction the acceptance by His Honor, the City Mayor of Ormoc City of the aforementioned donation;

RESOLVED FURTHER, that the deed of donation aforementioned be forwarded to the City Treasurer, Ormoc City for safe keeping and file;

RESOLVED FURTHERMORE, that whatever appropriation for the construction of artesian well in the barrio of Ormoc City, either coming from the city fund or from the pork barrel fund of Congressman Domingo Veloso, the barrio of Catayum, Ormoc City be given priority considering that there is already a donated site for the purpose by virtue of the aforementioned donation;

RESOLVED FINALLY, to furnish copy of this resolution each to the Director of Public Works, Manila; Hon. Domingo Veloso, Speaker Protempore, House of the Representatives, Manila; City Mayor, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; City Engineer, Ormoc City and the Barrio St. Catayum, Ormoc City.




