RESOLUTION NO. 152

4th indorsement dated September 26, 1951 of the
District Irrigation Engineer, Eastern Visayas Irriga-
tion District, Palo, Leyte hereunder quoted verbatim as
follows:

Respectfully returned to the Director of Public Works,
Manila.

The irrigation projects in the vicinity of Ormoc City
are included in our program for irrigation in this district.
Final survey for the completion of the necessary data for
the design of these proposed irrigation projects was started
in 1950, and only the Libertad and San Jose sections, roughly
comprising an area of 1700 hectares, and to be irrigated from
Cabugao & Bao Rivers, have been started and partially com-
pleted, when we ran out of funds in 1950 and survey work was
temporarily stopped.

As soon as sufficient funds become available, we shall
resume the final survey in order that full data can be sub-
mitted for the design of these proposed irrigation projects
around Ormoc City.

BE IT RESOLVED, as is hereby resolved, to respectfully
request the Hon. Director of Public Works, Manila that in
connection with the 4th indorsement above quoted, wherein

Ormoc City is already included in the program of work for irrigation project comprising an area of 1,700 hectares more or less which survey work has been started and partially completed and then temporarily stop for lack of funds and, so that the people of Ormoc would be actually benefited in this vast irrigation project of Eastern Visayas Irrigation District, that funds be made available for the continuation and completion of the irrigation system in Ormoc City;

RESOLVED FURTHER, to respectfully request the Hon. Director of Public Works, Manila that the irrigation program of the vast fertile land at Ormoc City is the concern of the city officials and the farmers of the city of Ormoc and that the early accomplishment of this project would solve the food shortage now locally prevailing and, therefore, the early release of funds to begin and accomplish finally the work is earnestly requested;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Director of Public Works, Manila; Hon. Domingo Veloso, Speaker Protempore, House of the Representatives, Manila; Hon. Mariano Cuenco, Senate President, Manila; Hon. Eugenio Perez, Speaker, House of the Representatives, Manila; City Mayor, Ormoc City; City Treasurer, Ormoc City; City Engineer, Ormoc City; the District Irrigation Engineer, of the Eastern Visayas Irrigation District, Palo, Leyte and to Mr. Protasio Escobar, City Agronomist, Ormoc City.
