RESOLUTION NO. 160

WHEREAS, the Municipal Board of Ormoc City has under its consideration the petition of Don Teodoro Conui, in representation of the heirs of Rufino Conui to give them free use of water from the Ormoc Water Works System in consideration of the use and benefit of the Ormoc Water Works System for a right of way on the installation of water pipe connection which traversed the land of said heirs of Rufino Conui located at barrio Patag;

NOW THEREFORE, the Board, on motion of Councilor Cleto P. Evangelista, seconded by Councilor Pablo S. Pajaron,

BE IT RESOLVED, is hereby resolved to respectfully inform the City Engineer, Ormoc City who is directly in charge of the operation of the Ormoc Water Works System to give a free use of water from the Ormoc Water Works System to the heirs of Rufino Conui represented by Don Teodoro Conui, the same privilege granted previously by the board to other applicants under similar circumstance, as a matter of equity and justice;

RESOLVED FURTHER, that this privilege for the free use of water granted to the heirs of Rufino Conui as above stated shall effect immediately on the approval hereof;

RESOLVED FINALLY, to furnish copy of this resolution each to the City Mayor, Ormoc City; City Engineer, Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; and to Don Teodoro Conui representing the heirs of Rufino Conui.
