RESOLVED FINALLY, to furnish copy of this resolution each to the

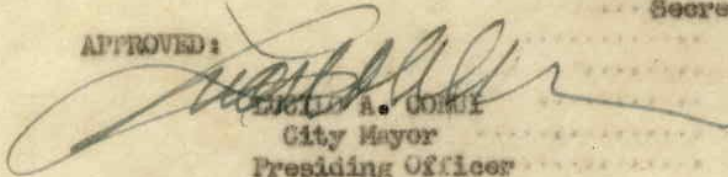
