RESOLUTION NO. 166

WHEREAS, acting on the petition of fish vendors on salted and dried fish in the new market extension, Councilor Felipe Adolfo suggested that the petitioners concerned be given five (5) days grace without paying the daily fees in the market stall for vendors on salted and dried fish in the event that the occupant or occupants of said market stall for dried and salted fish get sick; and upon due verification of the Market Superintendent concerned that the occupant or occupants is sick and no immediate member of the family or representative is available to run the daily business in his or her stall for dried and salted fish, the Market Superintendent shall upon notice to the City Treasurer concerned extend five (5) days allowance without paying the daily fees as required by Ordinance No. 7, Resolution No. 80 series of 1951, under Section 1-B-1.

NOW THEREFORE, in consideration of the above premises,

The Board, on motion of Councilor Felipe Adolfo, seconded by Vice-Mayor Marcelo D. Bandalan;

BE IT RESOLVED, as is hereby resolved, to give five (5) days allowance without paying the daily fees on vendors falling under B-1, Section 1 of Ordinance No. 7, Resolution No. 80, s. 1951 under the condition and circumstances above set forth.

RESOLVED FINALLY, to furnish copy of this Resolution each to the City Mayor, Ormoc City; to the City Treasurer, Ormoc City; to the City Auditor, Ormoc City and the Market Superintendent, Ormoc City.
